3.1 Riverview / QEHS Transportation

3.2 New Richmond High School Transportation

Following a meeting of the Transportation Committee on July, 19, 2018, the following recommendations were presented to Council:

- That Eastern Shores School Board enter into a four (4) year contract for the transportation of students attending New Richmond High School;
- That Trevor Renouf be authorized to proceed with a call for tender by invitation with three (3) different transportation companies;
- That Ms. Natascha Joncas, Director General, be authorized to sign for and in the name of Eastern Shores School Board, the transportation contract to be in effect for the beginning of the 2018-2019 school year, for a four year period ending on June 30, 2022.
