Mr. Gifford, Chairperson, called this special meeting of the Council of Commissioners to order and welcomed everyone present.

Before deliberations began Mr. Gifford, invited Ms. O'Rourke Mr. Dow, Ms. Boyle and Ms. Chatterton to express comments and concerns received from their membership.

Ms. O'Rourke expressed that despite the efforts, schools are not ready and that the anxiety levels are high among her members;

Mr. Dow expressed similar feedback from him members but especially regarding the 2-meter boundaries, as well as the lack of equipment. He expressed positive feedback regarding the respect of the directives.

Ms. Boyle explained than an enormous amount of information is coming to the Principals but that it is difficult to process and sometimes rushed. Because of this the workday, responsibilities and stress are greatly increased.

She feels that many are anxious with the various aspects of reentry and with distance education. Nevertheless, staff is supporting each other and working as a team.

Ms. Chatterton has not received any comments or concerns from her membership

Mr. Gifford thanked everyone for their comments and expressed how impressed and pleased he was with the leadership of the DG and with the team efforts to ensure that procedures are put in place to ensure the health and safety of all of ESSB's community.

Mr. Gifford asked Mr. Wood comment on the dossier. Mr. Wood began by talking about the last package that was sent to schools and centers with the procedures and measures to be taken for the reentry into the buildings, he spoke about the number of students returning and the status of personal protection equipment (PPE).

Members of public were asked to leave the meeting at 10:35. C. Carney and J. Davies left at that time due to previous commitments.

2 CONDITIONS FOR RE-ENTRY TO EASTERN SHORES SCHOOL BOARD SCHOOLS

THAT the Minister of Education be informed what schools and centres can safely open by the date announced by the Government of Québec; and

THAT the Minster of Education be informed which schools and centres cannot meet the requirements to safely open on the desired date and why.
