## 8. <u>CALENDARS</u>

### 8.1 <u>Amended Calendars – Modification to the Basic School Regulations (BSR)</u>

**WHEREAS** on October 28, 2020, decree 1128-2020 published a modification to the Basic School Regulations;

WHEREAS decree 1128-2020 modifies section 16 of the BSR to read as follows:

"... The school calendar for students shall consist of the equivalent of a maximum of 200 days, at least 177 of which must be devoted to educational services... to give effect to the first paragraph, 3 days or half-days devoted to educational services, as the case may be, must be deducted from the school calendar established for the 2020-2021 school year..."

**WHEREAS** the following calendars will be affected by the decree by changing the calendar from 180 school days to 177 and by increasing the training and planning days (fixed and floating pedagogical days) from a maximum of 20 to 23:

- Baie-Comeau
- Riverview, Flemming, Queen Elizabeth High School, Fermont School
- St. Patrick's, Evergreen High School
- Metis Beach, Escuminac, New Richmond High School, New Carlisle High School, ShigawakePort-Daniel School, Belle Anse, Gaspé Elementary, Gaspé Polyvalent and Grosse Ilse High School.
